

## Observers at COSSARO Assessment Meetings

The Committee on the Status of Species at Risk in Ontario (COSSARO) values the free and candid discussion among members because it informs status assessments and has developed an environment of mutual trust and professionalism. The attendance of observers at all or part of a COSSARO meeting may assist the Committee in achieving its mandate and roles. It is also valuable because it gives members of the public the opportunity to observe the operations of the Committee. We welcome observers to meetings of members of COSSARO at the discretion of the Chair of the Committee. Those wishing to attend as observers must apply in advance by email and agree to abide by COSSARO's rules of procedure and confidentiality.

Any person who wishes to attend a COSSARO meeting as an observer must apply in writing (email will suffice) at least three weeks prior to the meeting they wish to attend. The Chair will review each application, discuss it with members as appropriate, and provide a decision regarding attendance and availability of materials prior to the meeting. The number of observers attending may be limited by space depending on the venue. Permission from the Chair is valid for one meeting at a time.

Observers do not participate in Committee decisions and, at the discretion of the Chair, may be restricted to specific deliberations. Observers may address the meeting, and respond to members' questions, at the discretion of the Chair. Observers may be asked to leave the meeting room for *in camera* discussion at the discretion of the Chair. Observers are required to sign a declaration form indicating they will abide by the principles of impartiality and confidentiality (see below).

To promote free discussion by COSSARO members when assessing the status of wildlife species, discussions are confidential and details of these proceedings must not be disclosed by observers. Furthermore, to maintain the confidentiality of voting outcomes, observers will be asked to leave the meeting room during the voting of species' statuses. While not wanting to limit general access to meetings, it is intended that observer privileges be extended only to the extent that they do not inhibit COSSARO members from freely contributing to discussions and decisions.
